Sealed proposals will be received by the City of Greensboro, N. C., in the Planning Conference Room located at 300 West Washington Street, Greensboro, NC 27402, until 2:00 p.m., Thursday, November 5, 2009 the Elm Eugene Street Roadway, Median, Intersection and Sidewalk Improvements as shown in the plans and described in the Special Conditions.

Each proposal must be made on the blank forms provided in the bound copies of "CONTRACT AND SPECIFICATIONS", and must be enclosed in a sealed envelope and addressed to Mr. Don Saintsing, Engineering Division, 300 West Washington Street, Greensboro, N. C. The name, address and license number of the bidder must be plainly written on the outside of the envelope, and the envelope marked plainly with the contract name and number.

No proposal shall be considered or accepted by the City Council unless at the time of its filing the same shall be accompanied by a deposit with the City of Greensboro of a certified check on some bank or trust company insured by the Federal Deposit Insurance Corporation, in an amount equal to not less than five per cent (5%) of the proposal. In lieu of making the deposit as above provided, such bidder may file a bid bond executed by a corporate surety licensed under the laws of North Carolina to execute such bonds; conditioned that the surety will upon demand forthwith make payment to the City of Greensboro upon said bond if the bidder fails to execute the contract in accordance with the bid bond. This deposit shall be retained if the successful bidder fails to execute the contract within ten days after award or fails to give satisfactory surety as required herein.

A separate performance bond and payment bond each in an amount equal to one hundred per cent (100%) of the contract price will be required.

Consideration will be given only to proposals submitted by contractors licensed in the state of North Carolina under the Contractor's Licensing Act of 1925 or as amended.

The City reserves the right to waive any informality or to reject any or all bids or to award such contract as in its judgment is deemed to the best interest of the City.

No bidder may withdraw his bid within 60 days after the actual date of the opening thereof.

All contractors submitting bids (Prime and Sub) for this contract are required to be on the NCDOT's list of Prequalified Prime Contractors found on the following website:

City of Greensboro personnel will discuss M/WBE requirements. Also, the Engineer will be available to discuss the project and answer pertinent questions. All prospective bidders are encouraged to attend this pre-bid meeting.
